The Consultant should also be registered with an Association of Professional Engineers, and have at least five years' experience in experience in a civil engineering organization or equivalent technical organization with responsibility for infrastructure operations. A minimum of three (3) years of project management experience and preferably, successfully, managed or supervised at least one (1) project of at least US\$3 million dollars or higher which was financed by a multilateral financial institution is also required. The Consultant should have great interpersonal skills, excellent communication skills, be fluent in written and spoken English, be able to work independently and as part of a team, as well as be methodical, well-organized and reliable.

The Project Manager should have demonstrated knowledge of AutoCAD and Microsoft Project software. A working knowledge of the IDB's procurement, environmental and social policies are considered assets. The Project Manager should also have working knowledge of methods, sources and techniques of engineering design, road and drainage construction and maintenance; coastal protection infrastructure including hard, hybrid and nature based coastal protection interventions, and safety practices for personnel in construction sites. Specific experience in working with dredging, canal work, pavement design and/or construction, bridge design and/or construction, and sluice gates and pumping stations is preferred.
