The specific objective for tourism is to assess opportunities for introducing climate risk financing strategies in Belize's tourism sector to strengthen resilience to climate change and to formalize a climate risk financing strategy and implementation plan that will reduce the financial vulnerability of the sector in the face of climate change. The specific objective for agriculture is to design a climate risk management financial product geared specifically to small and medium-scale farmers, as part of the country's climate risk financing strategy for the agricultural sector.
