Submissions that do not provide the information required, or do not demonstrate the prospective contractor’s ability to perform satisfactorily, will not qualify and will not be considered for further evaluation.

Audited/un-audited financial statements for the years 2017 to 2020 will be reviewed to confirm the above.
(b) A demonstrable cash flow including access to credit (of which 50% must be in liquid cash from a commercial bank or credit union) of One Hundred Thousand Belize dollars (BZD100,000.00).
(c) Specific Experience as prime contractor in at least 3 (new build) building construction contracts within the last 10 years under the direct supervision of an independent design Engineer or Architect. Each cited project must include building works with an area of at least 1,500 SF with concrete masonry construction with electrical and plumbing systems (to comply with this requirement, works quoted should be at least 80 percent complete).
