(a) An average annual turnover (defined as certified payments received for works in progress or completed) within the best 2 of the last 5 years (the best two of the five years will be evaluated) of at least Four Million Seven Hundred Thousand Belize dollars (BZ \$4,700,000.00). Audited/un-audited financial statements for the years 2016 to 2020 will be reviewed to confirm the above.

(b) A demonstrable cash flow including access to credit of Nine Hundred Thousand Belize dollars (BZ \$900,000.00) of which BZ \$300,000.00 must be in liquid cash from a commercial bank or credit union.

(c) Specific Experience as prime contractor in at least 3 (new-build) building construction contracts within the last 10 years under the direct supervision of an independent design Engineer or Architect. Each cited project must include building works with an area of at least 13,000 SF with concrete masonry construction with electrical and plumbing systems (to comply with this requirement, works quoted should be at least 80 percent complete).
